

VOICES FOR PROGRESS

Membership in Voices for Progress (V4P) is by invitation only. Members commit to meaningful financial participation annually via a tax-deductible contribution to the 501(c)(3) Voices for Progress Education Fund (V4P Ed Fund) and/or a non-deductible contribution to the 501(c)(4) Voices for Progress. Legally, V4P members taking advantage of more than a preliminary amount of political advising services and programming must designate at least \$1,000 of their contribution to the 501(c)(4). All contributions are processed by the fiscal sponsors Tides Center and Tides Advocacy.
